Memorandum of Understanding

ABF is an autonomous academic institute, registered under Andhra Pradesh Societies Act (Reg No. 160/2007) and recognized by "Scientific and Industrial Research Organization (SIRO)" of the Department of Science and Technology. It is engaged in Research, Extension and Human Resource Development activities with focus on agribiotechnologies.

Biotechnology students of RBVRR Women's College may also visit ABF from time to time to expose themselves of the activities of ABF, with prior intimation.
- Preference will be given to Biotechnology students in Summer Internship in Biotechnology for Undergraduate Programme (SIBU) which ABF will organize every year.
- 3. The faculty of Department of Biotechnology may make use of the facilities of ABF for pursuing Ph.D. or Research interest. However, chemicals and consumables need to be met by RBVRR Women's College.
- 4. Any fee with respect to above facilities will be decided on mutual agreement.
- 5. The faculty of ABF and Department of Biotechnology RBVRR Women's College may also develop collaborative projects for external funding.
- ABF and Department of Biotechnology RBVRR Women's College may organize conferences, seminars, workshops etc.. jointly

- 7. The faculty of ABF may serve as guest faculty in the teaching programmes for the Department of Biotechnology RBVRR Women's College
- 8. The MOU is valid initially for a period of two years, extendable on mutual consent.
