WHERE AS, Sun Green Organics as a company formed in 2012, which provides socially and environmentally responsible solid waste management services, passionate about implementing simple solutions that are effective and helps our degraded environment, recover. Our country is facing The garbage issue and this is where sun green steps in and helps tackle this problem in a scientific way and ensures a clean and green environment. And are associated with Green Face NGO, Vizag and wet waste partners to ITC in there WOW (well-being out of waste) project to give solutions

WHERE AS, RBVRR Women's College, is the second oldest college for women in Hyderabad city to be conferred with autonomous ststus by UGC was established in 1954 by the Hyderabad MahilaVidyaSangham, (HMVS), a non-profit education society with a vision to be quality education institution in the region by enhancing, inspiring and empowering women specially those hailing from rural areas.

WHERE AS, RBVRR Women's College has approached Sun Green Organics and requested it to accommodate some of its students for doing their individual Project work in organic composting & also to impart practical training in organic waste of plant ,animal origin is converted into odour free raw compost for safe disposal or raw compost can be further processed into rich compost in just 10 days curing cycle. for its Undergraduate students (Botany)

WHERE AS, Sun Green Organics accepted the request of RBVRR Women's College and agreed to accommodate few students for doing their Project Work, imparting knowledge and Conducting Awareness programs on social responsibility to the students of RBVRR Women's College in its units under its guidance subject to the strictly adherence to terms and conditions by RBVRR Women's College & its students

Therefore, in consideration of the following conditions set forth in this MOU, the parties agree to the following.

- 1. Sun Green Organics would allow certain number of B.Sc (Botany) students of RBVRR Women's College, annually, for practical training in Giving solutions for individual homes, community composting, low cost solutions. to them, Conducting Awareness programs on social responsibility, and also permit for industrial visit for the students of RBVRR Women's College in its units under its guidance, subject to its prior written approval for each student.
- 2. The offer will be purely for training as per the requirement of your academic course and hence no service conditions relevant to Sun Green Organics employees will be applicable to the candidates who wish to do their Project Work and training at Sun Green Organics.
- 3. Sun Green Organics shall not provide any transportation or conveyance or food to the candidates. The Candidates should arrange for their own transportation and carry their own food, to and from the unit where they are getting training.
- 4. During the period for which the candidate undergoes her Project work at Sun Green Organics unit She should maintain strict discipline, decorum and should adhere to all

rules and regulations of the unit for the successful & timely completion of her assignment. The candidate should follow all the rules pertaining to the office/ work timings, Lunch etc.

- 5. This MOU would initially remain in force for a period of 2 years from the date of its execution and may be extended with the mutual written consent of the parties. However, the MOU can be terminated by either side by giving six months' notice to the other side.
- 6. Disputes if any would be resolved amicably. In the event if the dispute cannot be resolved in good faith between the parties within thirty (30) days after a party notifying the other in writing, the dispute shall be finally settled under Arbitration of Conciliation's Act 1996.
